- 27. No hoardings, banners, etc, will be allowed on the exhibition premises or on the roads in the venue unless their designs, specification, installations and location have been approved by the Organizers. Such unauthorised display is liable to be removed by the Organizers without notice.
- 28. Space not occupied:
 - a. Every exhibitor shall occupy the full area booked by him.

b. Should an exhibitor fail to take up stall, the Organizers reserve the right to dispose of the stall so unoccupied as they think fit.

- 29. The exhibitor may not assign, sublet or grant licenses in respect of the whole or part of the stand cards, advertisement, or printed matter of persons who are not bonafide exhibitors may not be exhibited or disturbed from any stand. An exhibitor may distribute cards, advertisements or printed matter in respect of companies or firms which are subsidiaries of exhibitors or exhibitor's ultimate holding company.
- 30. the Organizers and those authorised by them respectively have the right to enter the exhibitions premises at any time to execute work repairs and alterations and for other purposes.
- 31. No inflammable article may be stored in the exhibition area.
- 32. I/We undertake this participation at my own risk of contracting any disease including COVID 19 and The organisers will not be liable for any costs incurred or damages suffered upon, either direct or indirect, as a result of or incidental to such illness and I release the Organizers and the Show Manager from any liability of any kind arising there from.
